IV. <u>DIVISIONAL STATUS REPORTS</u>

A. Water Operations

- 1. One of the Water Operations Division's Fiscal Year goals is to maintain direct water treatment costs below \$750 per million gallons. For Fiscal Year 2023 (through August 2022), direct cost was \$778 per million gallons. Significant increases in chemical prices, above what was budgeted, is the main contributor to the overage. These numbers are through August 2022 which were reported last month; the most recent numbers are not available due to year end closeout.
- **2.** From November 7, 2022 December 4, 2022, the Bear Creek Water Treatment Plant operated at 49% of its capacity.
- **3.** The Authority has received renewed withdrawal permits from the Environmental Protection Division (EPD) for both Dog River and Bear Creek reservoirs. The permits expire in ten years.
- **4.** Results from quarterly samples for disinfection byproduct have been received. Location running annual averages (LRAA) for both Trihalometahanes (THM) and Haloacetic Acids (HAA) remain below regulatory requirements.
- 5. The Authority has received a two-year extension to its monitoring wavier for Synthetic Organic Chemicals (SOC), Asbestos and Cyanide. A monitoring waiver can be issued by the Environmental Protection Division (EPD) when previous testing indicates continued compliance, and the water system is not considered to be at high risk for the waivered contaminants

B. Wastewater Operations

- 1. One of the Wastewater Operations Division's Fiscal Year 2023 goals is to maintain the average direct wastewater treatment costs below \$1,950 per million gallons. For Fiscal year 2023 the average direct costs were \$2,146 per million gallons. These numbers are through August 2022 which were reported last month; the most recent numbers are not available due to year end closeout.
- **2.** The South Central Wastewater Laboratory recently received the Laboratory Quality Assurance Quality Control Gold Award from the Georgia Association of Water Professionals (GAWP). The award was presented at the GAWP Fall Conference in Jekyll Island on November 15th. This is the second consecutive year the lab has received the Gold Award.

C. Maintenance

1. During the period of November 5, 2022, to December 4, 2022, the Maintenance group completed 370 service orders (goal is 600). There are currently 268 open service orders in the work order system (goal is under 550) assigned to Maintenance.

- **2.** The Sewer Crews responded to 7 sewer back-ups; 6 were on the customer's side, one was on WSA's side. No damage and no spills were reported.
- **3.** The Leak Detection Crew surveyed a total of 67,172 feet (monthly goal is 88,000 feet) of water line on Thornton Road, Factory Shoals Road, and Riverside Parkway. Two main leaks, three service leaks, no hydrant leaks, no valve leaks and no meter leaks were found. Total estimated water lost was 17,280 gallons per day. No hydrant inspections were completed. All repairs have been made.
- **4.** The I&I Crew is not currently staffed. No new encroachments were documented this month. To date, 720 encroachments have been identified and 436 have been closed out.
- 5. The TV Crew inspected 1,200 ft of sewer line by TV camera. A total of 27,000 feet of SLRAT inspection was completed in South Central Basins. Additionally, they verified 4 laterals for sewer backups by TV inspection and assisted in the Southside force main cleanup and landscapes.
- **6.** The Vac Truck assigned to lift stations cleaned 25 lift stations. In addition, this crew had 5 days of dumping screenings at the plants due to the garbage truck being out of service and one day to clean the Sidestream screens. This crew also completed 2 hydro excavations for water.
- 7. The Vac Truck Crew assigned to sanitary sewer mains cleaned 5,100 feet of sewer mains, and 11 lift stations. This Crew also cleaned Northside Water Pollution Control Plant.
- **8.** Right-of-way Crew # 1 assisted with digging test pits on Southside force main and with the emergency repair that was recently discovered. Right-of-way Crew #2 has been working on the Rebel Trails Abandonment Project. They have installed the new force main and most of the new gravity sewer. The lift station area has been prepared and the wetwell should be arriving December 12th. Clearing cleanup and debris haul off is currently underway.
- **9.** The Manhole Repair Crew rehabilitated 28 manholes.
- **10.** The Air Release Valve (ARV) Crew inspected no ARV's. This crew has been on the Southside force main test project digging test pits for Hazen. To date 20 locations have been tested, and the testing is now complete. This Crew also has been working on the emergency repair of Southside force main.
- **11.** The Valve and Hydrant Crew inspected 76 fire hydrants and 0 valves.
- **12.** The Maintenance Group received two awards at the Georgia Association of Water Professionals Fall Conference. The Distribution and Collections Systems both received a Platinum Award for operation and maintenance.

D. Construction

- 1. Construction crews have completed installation of the new residential meters for the AMR/AMI project. This month 58 customer side valves were installed, for a total of 579 of the approximate 4,000 that were not installed at the beginning of the project. Two commercial meters were completed this month; crews have installed 60 out of 73 remaining commercial meters.
- **2.** The Construction Crew has completed the project to install approximately 1,500 feet of 2" West Liberty Road.
- **3.** The Construction Crew has started a project to replace the 2" galvanized water line on Adair Street between Church Street and Spring Street. This project is approximately 90% complete.
- **4.** A purchase order was issued to RDJE, Inc. to replace 20 fire hydrants under the Fiscal Year 2023 Hydrant Replacement program. This project is 0% complete.

E. Stormwater

1. WSA has completed replacing the corrugated metal pipe (CMP) with reinforced concrete pipe (RCP) in seven of the eight subdivisions addressed by WSA's Intergovernmental Agreement with Douglas County for subdivisions that do not have final plats approved. The completed subdivisions addressed include Beulah Ridge, Palmer Falls, Groover's Lake, Covered Bridge, Holly Springs, Grove Park, Winchester Farms. WSA plans to hire a contractor to replace the pipe in the Polk Place subdivision once the developer confirms the intent to build the subdivision as originally planned.

F. General Services

1. On November 22nd, a representative from WSA's insurance broker NFP assisted with open enrollment for employees who had life changing events or wanted to switch to the high deductible (HSA) coverage. 18 employees switched to HSA.

G. Public Relations

- 1. In mid-November, Maintenance Manager Chip Butts and Wastewater Operations Manager Keith Higgs both presented at GAWP's Fall Conference at Jekyll Island, Georgia. Mr. Higgs gave a presentation on WSA's wastewater plant aeration upgrades while Mr. Butts presented on the last 10 years of challenges with ductile iron gravity and forcemain sewer lines and how WSA's standards and procedures have been updated to rectify those issues.
- **2.** On December 2nd, 27 employees came out to volunteer in the downtown Douglasville Christmas parade as part of the WSA "float." Two lighted vaccon units and the WSA model water tower paraded down Church Street to welcome the holidays to Douglasville and also to remind our citizens to be cognizant of

not dumping fats, oils, and greases down the drain. Employees gave out over 200 pan scrappers and 80 pounds of candy to the festive crowd of on-lookers.

H. Finance

- 1. The Authority's Fiscal Year 2022 close out is continuing, with finalizing information into the Annual Comprehensive Financial Report (ACFR) underway and expected to be presented to the Board at the December 13, 2022 meeting.
- **2.** A 5% water and sewer rate increase went into effect December 1, 2022. A notice was placed on the water bills. Stormwater rates remain unchanged.
- **3.** The Low Income Household Water Assistance Program (LIHWAP), that is being coordinated through the Tallatoona Community Action Agency, began its second year of providing assistance for a total of \$272,185.67. This went towards paying balances for 601 WSA families.

I. Dog River

- **1.** From November 7 December 5, 2022, the Recreational Complex had the following attendance:
