Installation/construction cost quoted is for a standard connection or tap. Should there be additional work needed at the site, the cost may be higher. Construction cost for 2" - 10" meters are set and installed by individual firms, contractors/developers. For 8 & 10 inch fire line meter cost, use the meter cost displayed. The pricing for the large meters includes shipping and strainer cost (if needed). Meters shall be provided by the Authority at the Authority's current price plus a 10% handling fee.

An Application Fee of \$25.00 will be assessed at the time a new account is established. This fee will be on the customer's first bill. In the case of a new tap, the application fee will be paid at the time the tap fee is collected.

***Wastewater Rates***

A sewer treatment charge of **\$10.38** for Tier I and **\$12.13** for Tier II and III per 1,000 gallons is levied on 80% of water consumption for all meter sizes.

***Other Fees & Charges***

- \* Application Fee: \$25.00
- \* Fire Hydrant Meter Rental: \$1,250.00 deposit/\$25.00 per week rental fee.
- \* Trip Fee or Re-read Request: \$25.00.
- \* Same-Day Service Initiation Fee: \$50.00.
- \* Delinquent Account Restoration of Service Fee: \$50.00.  
After Hours Restoration/Same Day Fee: \$100.00.
- \* Unnecessary (as determined by the Authority) trip fee to the site - \$100.00.
- \* Late Payment Penalty: 15% of unpaid current past due charges.
- \* Returned Check Fee: \$30.00.
- \* Credit/Debit Card Fraud: \$50.00.
- \* Credit/Debit Card Use Transaction Fee: \$2.50 or 2.95% of the total dollar for charges over \$400.00.
- \* Stormwater User Fee: \$4.00 per Equivalent Residential Unit (ERU). The fee for non-residential properties is based on the actual area of impervious surface.
- \* Tampering with meters: 1st offense-\$100.00; 2nd offense-\$500.00; 3rd offense-\$1,000.00.
- \* Meter replacement cost = \$145.00 (cost is for residential size - 5/8" only).
- \* Damage to meter box, lid and AMR end point, etc. (caused by customer) = \$125.00 to \$500.00.
- \* Water usage on irrigation only meters for residential and commercial customers will be billed at the established third-tier retail rate,
- \* Sewer cleanout repair fee = \$50.
- \* For violations to the Authority's Rules and Regulations, the Authority reserves the right to charge a penalty of not more than \$1,000.00 per day per violation until the violation is corrected to the Authority's satisfaction.
